Camp Annual Report Form 27(A)

To: All Department of Ohio Camps

Brothers,

I imagine you have been collecting per capita dues in your camp. I urge all Camps to submit Form 27A & Per Capita Dues by April 10, 2010. This will allow the Department Secretary/Treasurer more time to compile the reports, to forward to National.

National Regulation Article VI Section 9 (Page 14)

The secretary of each Camp shall be required to send to the Department Secretary—together with the annual report required in Section 4 of Article VI, Chapter 1, of these regulations to be sent in on the 30th day of April in each year—a list of names and addresses (including zip code numbers) of all brothers carried on the rolls of the Camp.

National Regulation Article II Membership Section 3:

A Brother whose dues are not paid by March 1 may be dropped for non payment of dues by vote of the camp. A Brother so dropped from the rolls of the Camp shall be issued a General discharge for the Good of the Order.

INSTRUCTIONS Page five (5) of six (6) Pages of National Camp Annual Report Form 27(A).

All Camps must submit Form 27(A) Camp Status Report to the Department Secretary/Treasurer before April 30th. ALL FORMS (Except New Member Applications WILL BE TYPED.) National web site.

This form is not only an annual report to the department on your Camp status by report items since your last form 30, Camp Status Report. You shall not file form 30 for New Members after January 1, until form 27(A) is filed. All new brothers, drops, etc., since your last form 30 will be reported on form 27(A)

The Camp MUST SUBMIT FORM 27(A) IN DUPLICATE to the Department Secretary with all supporting documentation, check for all money due to National and Department before April 30th of each year. (One check payable to the Department of Ohio, S.U.V.C.W. The Department Treasurer deposits the check. He will write one check to the National Organization covering all Camps who have submitted.

THE CAMP ROSTER FOR THE CURRENT YEAR IN DUPLICATE.

REPORTING NEW BROTHERS: (Only use the current membership applications.)

The Camp keeps the original membership application form and documentation.

Check the National Web Site for updated forms.

CAMP FORWARDS DUPLICATE COPIES OF MEMBERSHIP FORM AND DOCUMENTATION.

Follow Page #5 of Form 27(A) instructions for Pro Rated Dues.

ALL FORMS (EXCEPT NEW MEMBERSHIP FORMS) MUST BE TYPED.

I urge all Camps to mail their Form 27(A) and Per Capita Dues in by April 10th, to Department of Ohio Secretary/Treasurer Allan Howey. This gives Brother Howey time to compile all the Camps Forms and Dues.
